## **VOTING CONDITIONS**

You must qualify as either a Depositing Member or Borrowing Member to be eligible to vote at the Annual General Meeting (AGM). Postal votes must be mailed so that they are received by Sunday, 18 July 2021. If you are voting online, all votes should be submitted by 11am on Sunday, 18 July 2021.



## **DEPOSITING MEMBER**

- a. To qualify as a Depositing Member, you must:
  - i. be at least 18 years old on 27 May 2021; and
  - ii. have held a deposit account with a company treated as a subsidiary of the Society to the value of no less than £100 on 27 May 2021; or
  - iii. have held a deposit account with a subsidiary of the Society to the value of no less than £100 on 27 May 2021.
- b. Where the deposit account is held jointly by two or more persons, only the first named person in the records of the Society in respect of that account is entitled to vote.

## **BORROWING MEMBER**

- a. To qualify as a Borrowing Member, you must:
  - i. be at least 18 years old on 27 May 2021; and
  - ii. owe a company treated as a subsidiary of the Society no less than £1,000 in respect of a mortgage debt on 27 May 2021; or
  - iii. owe a subsidiary of the Society no less than £1,000 in respect of a mortgage debt on 27 May 2021.
- b. Where a mortgage debt is owed jointly by two or more persons, only the first named person in the records of the Society in respect of that mortgage is entitled to vote.

## **NOTES ON VOTING**

- 1. You may use this form to vote online by 11am on Sunday, 18 July 2021. You may appoint the Chairman of the AGM or anyone else as your Proxy; and they do not have to be a Member of the Society. Your Proxy may vote for you at the AGM, but only on a poll. You may direct your Proxy how to vote at the AGM. Your Proxy may not speak at the AGM except to demand, or join in demanding, a poll.
- 2. If you want to instruct your Proxy to vote for or against any of the resolutions overleaf, please place an '**X**' inside the appropriate box. If you don't vote for or against a resolution, your Proxy will be free to vote or abstain from voting on that resolution, as they see fit.
